The NX Touch is a powerful yet simple control surface for the ONYX platform. Fully compatible with all ONYX consoles and PC software, NX Touch is a plug-and-play solution with an innovative control surface like no other lighting console.

14 touch faders allow control of playbacks and fixture parameters while 20 velocity-controlled pads allow for new types of effects. Additional programming buttons, such as Record, Edit, Update, Load, and Clear, are accessible directly from the NX Touch control panel. NX Touch includes one DMX port for direct control of any compatible DMX device.

# SOFTWARE

Operating the NX TOUCH requires the use of a Windows PC running ONYX, which can be downloaded from the support website http://support.obsidiancontrol.com.

You must update your controller to the latest version of ONYX before using it for the first time, and periodically check the website for updates.

# PC SYSTEM REQUIREMENTS FOR NX TOUCH

The NX TOUCH was designed to operate with an external PC. Although it can be used with any PC system, the ONYX controller software was designed around a touch screen interface, and without one, will be more difficult to use.

# **SETUP**

## **USB**

The NX TOUCH draws its power from the connected computer via USB. If you use a USB hub, it must be powered. The host PC will fail to recognize a NX TOUCH device that is connected via an unpowered USB hub.


When the NX TOUCH is connected for the first time to a computer running ONYX software, a driver will be installed on the computer. As soon as the driver is loaded on the computer and initialized, the NX TOUCH is ready for use.

## **DMX**

Connect fixtures to the DMX port of the NX TOUCH device using a DMX cable and standard DMX 512A pinout. Do not use microphone cable.


Use a DMX termination plug on the last fixture on the DMX link.

Damage to the NX TOUCH device or to the connected computer due to faulty DMX wiring is not covered by the product warranty.



You can configure the NX TOUCH from the host PC once the system is installed.

- DMX Out: 1 x 5-pin locking XLR
- USB Input: USB 2.0 B. The NX TOUCH can draw a maximum of 500mA. If using a USB hub between the NX TOUCH and the host computer, make sure that the USB is powered.

As any electronic device, the NX TOUCH requires periodic cleaning. The schedule relies on the environment in which the controller is operated. An Obsidian Control Systems technician can provide recommendations if necessary.

Never spray cleaner directly onto the device; always spray into a lint-free cloth and wipe it clean. Consider using cleaning products designed for cellphone and tablet devices.
