We reserve the right to reject trade-in wireless systems from customers if we determine that the systems or components were not legally acquired by the consumer, or if the systems or components are counterfeit.

5. Limit four (4) rebates per person. Each rebate must be submitted on an individual form. Void where prohibited or taxed. We reserve the right at any time, without notice, to suspend, terminate, or alter in any respect this or any related terms or conditions. Our decision regarding Promotion eligibility and other matters related to this Promotion are final.
